FINAL EMPANELMENT NOTICE No. 02

On being agreed upon the terms and conditions laid down in the preliminary notice of empanelment for Galvanized Mild Steel Tubes (GI Pipes) manufacturers vide No. PHE-37/JJM/PB/2022-23/T-21684 dated.16.02.2024 and on submission of requisite empanelment security and on signing the Contract Agreement in prescribed format, the final empanelment notice against this office **EOI No. 42 of 2023-24** of this office for “Empanelment of Manufacturers of ISI marked (own make) Galvanized Mild Steel Tubes (GI Pipes) of various sizes to be utilized against different PWSS at different locations of Assam under JJM Assam under PHE Department” is issued hereby.

TERMS & CONDITIONS:

1. ITEM & SPECIFICATION : Galvanized Mild Steel Tubes (GI Pipes):

ISI Marked (Own Make) Galvanized Mild Steel Tubes Class Medium (continuously welded) Electric Resistance welded (ERW)/ high frequency Induction (HFIW) /Hot finished welded (HFW) Tubes of screw at both ends as per IS: 554/75 with amendment No. 1 for pipes threading one end fitted with sockets and other end protected with plastic thread protector in random length of 4 to 7 meters conforming to and Marked IS: 1239 (part-I) 2004 with up-to-date amendment, current at the time of delivery and size ranging from 50 to 300 mm dia.

Each Pipe shall have as cast or stamped or legibly and indelible painted. The marking shall show the following:

- a) The Manufacturer's name or trade mark.
 - b) ISI Marking with No.
 - c) The letters “JJM ASSAM”
 - d) The nominal diameter of pipes
 - e) Year of Manufacture
 - f) Brand Name
 - g) Batch Number
 - h) Class of Pipes
 - i) Any important information that the manufacturer deems fit to be inscribed on pipe.
2. **Empanelment of the manufacturers:** The agreement shall be entered in to for empanelment only, without any commitment of supply order from the department. The Department will only empanel the manufacturers on the basis of their technical qualification for supplying the pipes through willing contractors and no such purchase will be carried out by the Department at its own.
 3. **Period of Empanelment:** The period of empanelment is for one (01) year from the date of issue of this notice subject to extension on mutual agreement of both parties at same terms and conditions.
 4. **Forfeiture of security against Empanelment:**
The security deposited by the empanelled manufacturer shall be forfeited (a) if he fails to execute the supply contract within specified time period/ poor delivery track record, and (b) if the manufacturer withdraw the rate contract without prior information to the Department, and (c) in case of non adherence to any terms and condition prescribed in the EOI Document.
 5. All the terms and condition defined in the Bid Document against EOI No. 42 of 2023-24 shall be binding and govern the empanelment period.
 6. The rates shall be fixed and paid by the contractor with mutual agreement with the empanelled manufacturer. Regarding the rate and payment against the materials supplied to the contractor for any work, the department will not be a party for any breach of contract between the empanelled manufacturer and the contractor.

7. **Testing Certificate:** In addition to furnishing manufacturer's test certificate by the empanelled manufacturers, each lot of materials supplied by the manufacturers must be got inspected by "Central Institute of Plastics Engineering & Technology" (CIPET) or any other notified testing agency from the Department before delivery and the test certificate is to be submitted with materials so delivered to the contractor and the contractor in turn must have to submit the same to appropriate authority of the indenting Division.
8. **Jointing of Pipes:** The empanelled manufacturers will have to provide necessary technical support to the contractor in the field regarding jointing of the pipe materials including imparting necessary training of contractor's personnel, providing but/fusion welding machines on loan/ hire basis etc.
9. **Delivery Schedule:** The materials should be delivered to the indenting destinations within 20 days from the date of receiving of Purchase Order and initial payment from the contractor. To keep a track of the delivery milestones, the empanelled manufacturers will have to make necessary entries in the PIDMS (Pipe Inspection & Delivery Management System) portal hosted in JJM Assam website (www.jjmassam.in) failing which the Mission Directorate will be at the discretion of withdrawing their empanelment and debaring from further participation without any further correspondence. The Mission Directorate will facilitate in creating the login credentials of the empanelled manufacturers under the PIDMS portal.
10. **PIDMS portal:** The manufacturers shall have to make entries against all the relevant parameters in the PIDMS portal as defined in the Bid Document. Strict monitoring of the PIDMS portal shall be conducted and lapses in any case shall invite punitive sanctions as per laid down norms.
11. **Post Delivery Inspection:** The Department shall conduct random post delivery inspection of pipes through a computer based selection mechanism.
12. **Penalty:** Non adherence of the Terms of Reference in the Addenda and SOP described above by any of the active empanelled pipe manufacturer shall invite withdrawal of empanelment followed by forfeiture of entire Performance Guarantee available with the Department till that time. Offences of serious nature involved in compromising the quality of the Mission shall lead to debarment of the entities and punitive sanctions as per Clause No. 46 defined in the Assam Public Procurement Act 2017 shall follow.

The Mission Directorate, JJM Assam reserves the right to cancel/withdraw the empanelment process without assigning any reason thereof. Also the empanelment of the manufacturers may be withdrawn, on the ground of any adverse report from field or inability to supply required materials within stipulated time period.
